## REVISED FINANCIAL REGULATIONS WITH EFFECT FROM 1st May 2023

#### A. The revenue of the Association will Include:

- 1) Membership / Subscription to be paid by Affiliated Associations / institutionalMembers / Life Members / Patrons.
- 2) Recognition Fees to be paid by the Organizers of International / All India / State level Tournaments.
- 3) Players / Arbiters Registration fee.
- 4) Grants from Government.
- 5) Grants from AICF.
- 6) Sponsorship.
- 7) Donations.
- 8) Advertisement.
- 9) Interest on Deposits.
- 10) Change of state charges.

#### **B.** Affiliation Fee:

Each affiliated unit shall pay to the Association the annual subscription of Rs.1500/- (Rs. One Thousand Five Hundred Rs. Only) before 15<sup>th</sup> of April or with a fine of Rs. 500/- before 30<sup>th</sup> April of that financial year.

If any unit defaults to pay annual affiliation fees its membership will be automatically suspended.

# C. Entry Fee:

## **State Championship**

Entry Fee at the rates and in the manner indicated below shall be levied for State Championships through online mode in CGSCA account and 50% of which shall be paid to the Host towards its share.

The entry fees mentioned on account of every player shall be paid by his / her respective District Association / Affiliated Unit / Entity / Player to Chhattisgarh Pradesh Shatranj Sangh within the time limit prescribed by the Organizers. The entries received after the stipulated time will be accepted by CGSCA with a late fee of Rs. 250/ - per player within the time limit prescribed by the Organizers. No entry will be entertained thereafter.

CGSCA will pay 50% (Fifty percent) of the entry fee share as well as late fee received to the Host by Bank Transfer before conclusion of the championship, if any government grant/financial assistance is not available to organizer of that event.

The entry fee once paid shall not be refunded if the withdrawal from championship is done after the publication of first round pairings.

The players representing from the units of Bastar & Sarguja Divisions, shall be entitled to 50% (Fifty percent) concession in entry fee subject to confirmation everyyear.

**Protest:** Protest, if any, against the decision of the Chief Arbiter shall be made in writing with a protest fee of Rs.1500/- within prescribed time limit in the prospectus after occurrence of the incident and any Fair Play Violation complaint need to be lodged within 2 hours witha complaint fee of Rs. 2000. The protest/complaint fee will be refunded if the appeal is upheld.

**Recognition Fee:** For all state level tournaments 5% (of the total prize fund) in which government grant is not sanctioned and 15% where government grant is available.

D. Players Annual Registration Fees : Rs. 150/-

E. Arbiter Registration Fee : Rs. 500/-

### F. Traveling Expenses:

1. Second class railway fare / Bus fare will be reimbursed to the Office Bearers, Executive Members and Authorized Representatives of the affiliated unit. Anyone specially deputed in connection with the tournaments / meetings / association works will be also reimbursed his traveling expenses. He shall also be eligible for being reimbursed with the actual hotel expenses on production of proper bills.

## G. Conditions of Services of the Secretariat Staff

- 1. The number and the category of the secretarial staff to be engaged and the remuneration and other benefits which they will enjoy will be decided by the Committee.
- 2. The working hours of the CGSCA Secretariat shall be from 10.30 AM to 6.30 PM
- 3. All Sundays and Central Government public holidays shall be holidays for the CGSCA Secretariat provided however that no member of staff shall decline to work on such holidays in the event of an exigency.
- 4. The Secretarial Staff shall also be eligible for twelve days of non-cumulative casual leave in a Calendar year subject to the condition that not more than three days of the leave shall be availed of at a stretch otherwise than on medical ground and also that leave shall not be claimed as a matter of right.
- 5. Medical insurance reimbursement for self (permanent staff) will be subject tomaximum Rs 5,00,000.00 (Five lakhs only)

- **\$** Apart from the above, the Chief Arbiter, Deputy Chief Arbiter and DGT Operator shall be reimbursed to & fro 2<sup>nd</sup> class Rail fare / Bus fare, free Board & lodge apart from local transportation. Arbiters required to be provided with free Board & lodge.
- # Only approved Arbiters by CGSCA shall officiate in the tournaments.

#### I. Coaches Remuneration:

FIDE Instructor - 4000/- per day.

Development Instructor - 3000/- per day.

National Instructor - 2000/- per day.

CIS Instructor - 1500/- per day.

Coaches will be paid the above amount per day subject to making themselves available for four hours daily at the venue decided by the CGSCA.

## **State Player's Participation in National Championship:**

- (i) Each Player who has been representing the state in the National Championship (Seeded and Selected) should be paid a minimum amount of Rs.200/- per day. The boarding expenses given by the All India Chess Federation to the normal entry player may be reduced from the total amount payable to the player.
- (ii) The player should be paid Concessional Second Class Train Fare from home town to Championship and back.
- (iii) The normal entry fee for the National Championship should be borne by the State Chess Association.
- (iv) Dress Code: Minimum 2 T-Shirts each (with the State Association name) will be supplied to all the players who are representing the state either through normal or special entry. For the normal entry the State Association has to bear the cost and for the special entry the

cost of the T-shirts may be collected from the concerned player.

#### **Fees for the Tournaments:**

- (i) Entry fee should not be more than 0.5%, if the tournament concludes within 5 days and 1% of the total prize fund if the tournament concludes more than 5 days.
- (ii) The above conditions will not be applicable for State Selection Championships.
